RESOLUTION 1: Minutes of the 2022 AGM

RESOLUTION 2: Financial Statements

The trustees are required to present to the Annual General Meeting (AGM) the audited accounts and the Trustees' and Auditor's Reports for the financial year ended 31 August 2022.

A summary of the Consolidated Statement of Financial Activities and Balance Sheet for the last financial year is published with our Annual Review. A full version of the audited Financial Statements is available on our website, www.highgatecemetery.org. Any member wishing to have a printed copy of this material should contact the office.

RESOLUTION 3: Auditors

The auditor is appointed at every general meeting at which accounts are presented to members. The current appointment of Knox Cropper Chartered Accountants as the Charity's auditor will end at the conclusion of the AGM and they have indicated that they are willing to stand for reappointment. It is normal practice for trustees to be authorised to agree how much the auditor should be paid and Resolution 3 grants this authority to the Board.

RESOLUTION 4: Election of Trustees of the Charity

This year there are three vacancies created by the retirement by rotation of Doreen Aislabie and Eve Wilder, who are required to step down having reached the end of their permitted terms, and the resignation of Nicola Jones.

Following best practice as recommended by the Charity Commission, the Board seeks to recruit new trustees who can make a strong contribution to its work. To do this, the Board identified which skills and experience it needed to complement those of existing trustees and sought applications from suitable candidates.

This year, the Board sought candidates with experience of oversight of large projects, fundraising or finance, or other relevant knowledge and experience. We particularly welcomed applications from a diversity of perspectives. The vacancy was advertised on our website, on Twitter and LinkedIn, as well as through a number of networks.

A nominations committee was set up to interview new candidates

and to recommend to the Board which should receive their endorsement, considering their individual skills and experience and their ability to work well as part of a team. The nominations committee consisted of Katy Baldwin, Liz Fuller and Stuart Orr.

After considering the report of the nominations committee, the Board recommends that members vote in favour of the election of Paul Candler, Claire Jebson and Charo Rovira.

- The votes will be counted by our Proxy Officer and published on our website in due course.

My career as a senior civil servant in several Government Departments has allowed me to develop extensive strategic and administrative skills, and I have a strong track record in particular of overseeing large projects, as a graduate of the Major Projects Leadership Academy at Oxford University's Business School.

My various roles in Whitehall have involved significant representational duties (including media appearances) and complex stakeholder management. I am very comfortable understanding and acting within the legal framework of trusteeship, and have wide experience of navigating complex financial and people issues both directly and in an advisory/Board capacity.

Drawing on my wide experience of Board membership, I would bring a strong drive for collaboration and consensus, but also a challenging and independent mind. I offer too full commitment, energy and enthusiasm in pursuing the Trust's aims.

I have been project curator for major exhibitions at the British Museum and I currently work at the Library of the Institute of Classical Studies where I also uncover stories from the past through its archival collections.

Appointed trustee

RESOLUTION 5: Appointment of Trustee

Under our Articles of Association, there are up to three trustees who are appointed by the Board on the basis of their specialist skills and experience. They are called 'appointed trustees'. Such appointments take effect only when approved by the members at an AGM.

Martin Adeney, who was reappointed in 2020, has reached the end of his second term and so cannot stand again. Martin had very strong connections with local people and organisations.

In his place Trustees have appointed Simon Edwards, who is Honorary Secretary of the Highgate Literary and Scientific Institution and so maintains these local links while also already being a volunteer guide at the Cemetery.

The Board now seeks approval for the appointment of Simon Edwards.



SIMON EDWARDS

I have lived in Highgate most of my life and have been a volunteer guide at the Cemetery for the past three years, a role which I have hugely enjoyed, explaining the history and context of this extraordinary Highgate attraction, which is known around the globe.

Prior to retirement, I was a director of the property services company, Savills, where I had a long career advising high net worth clients about the best strategies to maximise both capital and

income from their property assets. As a cemetery volunteer, I have used my communication skills and interest in Victorian history, but I believe that I have a wider set of skills to offer the charity.

I currently volunteer for two other historic local organisations, as honorary secretary for one and a trustee for the other. I offer myself as a FOHCT trustee because I would like to work with the other trustees to assist in safeguarding the future of this heritage asset of national importance, both as a working cemetery and a world class visitor destination.

Completing the Proxy form

As a member of the Charity you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote at a general meeting of the Charity. You can appoint a proxy using the form enclosed with this mailing. You may only appoint a proxy using the following procedures.

Appointment of a proxy does not preclude you from attending the meeting and voting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.

A proxy does not need to be a member of the Charity. If you appoint a proxy other than the Chair your proxy must attend the meeting. To appoint as your proxy a person other than the Chair of the meeting, set out their full name and address in the space provided. If you sign and return the proxy form with no name set out, the Chair of the meeting will be deemed to be your proxy. Where you appoint as your proxy someone other than the Chair, you are responsible for ensuring that they attend the meeting and are aware of your voting intentions. If you wish your proxy to make any comments on your behalf, you will need to appoint someone other than the Chair and give them the relevant instructions directly.

To appoint a proxy using the proxy form, the original form must be:

- completed, signed and dated;
- posted to: The Proxy Officer, Friends of Highgate Cemetery Trust, Swain's Lane, London N6 6PJ;
- received no later than 5pm on Monday 15 May 2023.

Any power of attorney or any other authority under which this proxy form is signed (or a duly certified copy of such power or authority) must be included with the proxy form.

If you wish your proxy to cast your votes for or against a resolution you may insert an 'X' in the appropriate box. If you do not want your proxy to vote on any particular resolution, you may insert an 'X' in the 'Vote withheld' box. A 'vote withheld' is not a vote in law and is not counted in the calculation of the proportion of the votes for and against the resolution. If you do not indicate how your proxy is to vote, you will be deemed to have authorised your proxy to vote or to withhold your vote as your proxy thinks fit. Your proxy will also be entitled to vote at their discretion on any other resolution properly put before the meeting.

Board voting recommendations. The Board considers all the resolutions are in the best interests of the Charity and, accordingly, recommends that all members vote in favour, as they themselves intend to do. If you do not tell the Chair how to vote, he will vote in this way. The notes to the agenda on page 7 explain how voting works.
